Ladies and Gentlemen,

We would like to inform you of a conference held in The Netherlands June 23 and 24, 2009 with the aim of better harmonizing efforts on the frontline and improving the quality of animal welfare during transport.

During this conference, veterinarians and approved & authorized Live Animal Transport Inspectors from various Member States expressed deep concern about the situation of live animals being transported throughout Europe.

Our many years of experience give us the impression that there is

- no approved or evidence-supported conformity regarding technical requirements of the vehicles appropriate to the species, numbers, size and age of the animals being transported, nor of the stocking density
- insufficient communication between the Member States for solving problems ,
- unequal implementation of performing on-the-spot inspections in different Member States and thus
- the possibility for transporters to carry out animal transportation through countries with no or insufficient controls.

We came to the conclusion that there are urgent needs to improve the system in all countries of the European Union, and during the conference session "Putting our Thoughts Together" we put these needs down on paper to create this memorandum.

There is a need for:

- clarifying the provisions of the transport legislation,
- educating the persons involved in and dealing with live animal transport,
- precluding shortcomings in dealing with living beings,
- enabling the authorities to judge correctly non-suitable equipment used for transport and discern situations of poor animal welfare,
- forcing transporters, according to article 3 (f), to use the fastest route and
- installing more effective measures to avoid repeated violations.

With regard to the legislation directly pertinent to animal welfare in transport and also taking into account Animal Health legislation and TRACES, we, Veterinarians and Live Animal Transport Inspectors, strongly recommend the following adjustments:

1. The European Food Safety Agency (EFSA) (Panel on Animal Health and Welfare), after consultation with the companies building the lorries, must define and set standards for drinking devices, for partitions, for moving floors, for ventilators, for navigation systems and other prods used on-board vehicles designed for live animal transport. Our group is willing and able to make available a check-list (with photographic examples) to EFSA, illustrating suitable and unsuitable equipment that EFSA can then make available to the public.

This EFSA approved check-list must form the basis for amending the Regulation (EC) 1/2005, thus eliminating non-suitable equipment on vehicles.

2. The European Commission must clarify and specify the following details of the regulation:
 - the minimum age when an animal is considered “weaned” under the transport regulation,
 - space allowances for swine of all ages/weights, as well as lambs and kids,
 - the circumstances in which animals need to have extra space
 - the exact start of a journey (this varies according to the different translations of the regulation and due to the different interpretations of the range of the judgement in Case C-300/05 of the Court of Justice of the European Communities) and
 - the minimum amount of space above the highest point of the animal that must be granted to each species.

3. The TAIEX-instrument (Technical Assistance Information Exchange) of the DG Enlargement as well as the DG SANCO must provide their knowledge with the goal of achieving uniformly-educated transport attendants as well as transport inspectors in all Member States regarding live animal transports, so that a harmonized approach to animal welfare provisions is achieved.
4. The European Commission must grant full, European-wide access to TRACES for all official inspectors. It should be set in such a way that by plugging the ID of an animal one can trace its entire earlier and current movements.
The European Commission must also provide a European-wide database listing all authorizations of European transport companies and their certificate of approval for means of transport to all official inspectors
5. The European Commission must make public their replies to FAQ (Frequently Asked Questions) on their webpage and keep it updated.
6. The European Commission must provide and guarantee better translation of the regulation.

7. The European Commission must require that vehicles used for short-distance also have a certificate of approval for means of transport, as well as bedding for all animals.
8. The European Commission should take action so that the drivers' transport time is harmonized with the rest/feed/and water intervals for animals in transport.
9. The European Commission must insist that veterinarian inspectors from Member States harmonize the loading density with the maximum lorry weight allowances in those countries that will be transited by their transport consignments, so as to avoid immobilization of the vehicle by highway police abroad.
10. The European Commission must require live satellite tracking and tracing systems of animal movement.
